#### **Terms and Conditions**

# **Background to Promotion**

- Mirvac Victoria Pty Ltd (ABN 42 006 708 363) of Level 8, 1 Southbank Boulevard, Southbank VIC 3006 (Mirvac or the Promoter) recently introduced the \$20,000.00 GlobeWest Furniture Voucher promotion exclusively for two-bedroom townhomes (limited to lots 141, 163, 164) for sale at The Fabric by Mirvac, Altona (Promotion).
- The Promotion will run for a limited time. The Promotion commences at 10:00am on Tuesday 16<sup>th</sup>
  January 2024 and ends at 5:00pm on Sunday 31st March 2024 or unless sold out prior
  (Promotion Period).
- 3. Under the Promotion, subject to these terms and conditions, Mirvac will offer a \$20,000.00 (including any GST) furniture voucher that can be used to purchase GlobeWest furniture and/or accessories (**GlobeWest Voucher**) to Eligible Buyers who purchase a two-bedroom townhome (limited to lots 141, 163, 164 subject to availability) listed on the pricelist for Stage 4 as at 15<sup>th</sup> January 2024 at The Fabric by Mirvac, Altona (**Eligible Property**) during the Promotion Period.
- 4. The following terms and conditions apply to the Promotion. By participating in the Promotion, Eligible Buyers agree to be bound by these terms and conditions.

#### **Promotion Terms and Conditions**

The Eligible Buyer will only be entitled to take part in the Promotion and receive the GlobeWest Voucher if the following terms and conditions are satisfied:
