

TERMS AND CONDITIONS FOR EAST VILLAGE 'SPEND, SPIN AND WIN' PROMOTION

1. Information on how to claim and gifts form part of these Terms and Conditions. Participation in this SPEND, SPIN AND WIN Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.

ELIGIBILITY

2. Subject to condition 4, this Promotion is only open to Australian residents aged 18 years or over.
3. GENERAL

8. Each individual is only permitted to make one (1) gift claim per day promotion period under this Promotion. Incomplete, indecipherable or illegible claims will be deemed invalid. Any gifts that remain left over at the conclusion of the Promotion Period will remain the property of the Promoter. Gift recipients will be advised immediately at the time of claim submission.

9. The Promoter reserves the right, at any time, to verify the validity of claims and claimant's (including a claimant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the claim process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
